### Overview

### Code of Conduct

Birali Steiner School expects that parents and guardians will:

- \* support the School ethos and values
- \* show an active interest in their student's schooling and progress
- \* cooperate with the school and demonstrate behaviour that achieves the best outcomes for their student
- \* support school staff in maintaining a safe and respectful learning environment for all students
- \* initiate and maintain constructive communication and relationships with school staff regarding their student's learning, wellbeing and behavior
- \* contribute positively to behaviour support plans that concern their student
- \* use appropriate channels of communication to relay any concerns, ideas or questions relating to teaching and learning, pastoral care, or any assistance and service they or their student have received from Birali Steiner School.
- \* not directly approach another person's child. The school will manage issues between students according to school policy and processes.
- \* use the processes and procedures in the Birali Steiner School's Complaints Policy for complaints and grievance resolution

### Consequences of Unacceptable Conduct

Birali Steiner School expects its entire staff to engage professionally, competently and courteously with all parents and guardians. However, when Parent/Guardian conduct infringes upon staff's inherent right to be treated with civility and respect, Birali Steiner School reserves the right to:

- 1) Limit parent's physical access to the school or school activity;
- 2) Limit parent's communication with staff; and,
- 3) if no resolution can be reached, and/or in cases involving repeated verbal, physical or emotionally abusive, intimidating or threatening behaviour, terminate the enrolment contract of the student. The Principal of Birali Steiner School is authorised via legislation (Education (General Provisions) Act 2006) to give direction to leave and not re-enter the premises for a specified period of time, and may utilise this right in response to inappropriate parent conduct.
